Dear Parents

As you are aware, Sunday, 10th May 2020, will bring us the latest update from government.

In readiness for what we may expect from this announcement, I wanted to start talking to you about your children's return to nursery.

Some parents have been in touch to let us know of any potential changes to childcare needs. If you think you may need to make any changes, please can you let us know at the first possible opportunity to help us support yourselves and our business continuity.

I appreciate that some of you may feel a little anxious about your children returning. Attached for your perusal is our COVID-19 Setting Operating Procedure. This document will inform you what we have put in place to ensure yourselves, your children and our staff remain safe within our setting in respect of the current pandemic. I hope you find this document helpful.

As you are all aware, we have remained open during lockdown, supporting childcare needs of critical key workers and vulnerable children. This has given us an opportunity to give the setting a complete overhaul as mentioned in my last email. The setting is really taking shape and I am hoping that all the new resources ordered will be in place in readiness for your return but much of this is dependant on current delivery timescales. What I am delighted to share however is that all the decorating has been completed inside and we are now starting on the outside. The final larger pieces of work which commence w/c 18th May, will be our outside decking and covered play areas and internally, the installation of new sink areas in both the toilets and childcare rooms, supporting children to access hand-washing more easily and regularly.

Our team will be taking part in virtual training prior to their return, in readiness to support your children's emotional well-being and of course, cuddles will be readily available in abundance!

We have a detailed COVID-19 Risk Assessment which sets out in more detail our safe practices, especially around hand washing, social distancing, PPE, wellbeing and management of any child or member of staff who may have symptoms. I am happy to send this out to you if you would like to view this document prior to your return.

Both documents will also be uploaded to our website in due course.
